## President's Message

Greetings, REAVC members.



**Be Sure to Sign up by November 20th for the December 3, 2019, Holiday Luncheon!**

The Holiday Luncheon reservation form is included in this newsletter. Beginning with the December 2019 REAVC luncheon and for future luncheons, the reservation form and fee must be received by approximately 10 days prior to the luncheon. The deadline will be printed on the reservation form. The reservation form and fee must be received by November 20th for the upcoming Holiday Luncheon.

The majority of folks responding to the luncheon survey preferred to pay a fee rather than reduce the number of luncheons or change the venue. Another big reason for the reservation and fee is to reduce the number of "no shows" at the luncheons. Many folks would reserve a space at the luncheon but would neglect to let us know they were not going to attend within the requested time. This has resulted in a loss of up to \$700 or more at each luncheon at our members' expense.

We received comments from some of our REAVC members at the last luncheon regarding the luncheon fee. A few said they would prefer to increase the dues rather than charge a fee for the luncheons. Since dues were recently increased, the REAVC Board determined it was more equitable to charge a fee for the luncheons. We'll see how well this all works out at the next luncheon. The present fee can be modified as needed. There was a concern that some folks who currently attend the luncheon would (*Continued on Page 2*)

## Board of Retirement Report

The Retirement Board did not meet during the month of August. It has traditionally gone “dark” for

that month, so there is not too much to report.

At its September 9 meeting, the Board was informed that the election was underway to fill the General Member seat formerly occupied by Dan Shapiro for the remainder of the term. The results are expected to be available by the Board’s September 23 meeting.

Also, at the end of the same meeting, Public Member Robert Bianchi informed the Board that he was resigning from his seat effective immediately. He was moving out of Ventura County to be closer to his children, so would no longer be eligible to serve. The Board Members expressed their appreciation for his capable service and wished him well. It will be interesting to see how long it will take the Board of Supervisors to appoint a replacement to fill the vacancy.

July followed June in gaining value, with VCERA’s assets increasing 0.2% to \$5.91 billion. Markets declined in August as trade tensions between the U.S. and China resurfaced, and VCERA’s investment portfolio market value fell 0.9%, to \$5.83 billion.

The final net of fees rate of return for the 2018-2019 fiscal year was 7.2%, slightly lower than preliminarily projected, and slightly less than our targeted return of 7.25%. Largest detractors from fiscal-year investment performance were non-U.S., U.S. small and mid-cap, energy related stocks and enclosed retail shopping malls.

As a comparison, the total fund fiscal year rates of return for CalPERS was 6.7%, and 6.8% for CalSTRS.
