### **BOARD OF RETIREMENT REPORT - BY ART GOULET**



Since September, the public markets have continued to be erratic.

On a preliminary valuation basis, in the month of October VCERA's portfolio value rose 3.5% to \$7.97 billion. Although for the one-month period of November the portfolio value decreased 1.0%, for the longer one-year period ending November 30th, the portfolio was up 19.3%, with an ending market value of \$7.86 billion.

At its December 13th meeting, the VCERA Board of Retirement (BoR) re-elected Mike Sedell as Chair and me as Vice-Chair, for the 2022 calendar year. Also at the December 13th meeting, and again at the January 3, 2022 meeting, the Board re-affirmed meeting the legally-required criteria to continue meeting remotely for the next 30-day period because of COVID. Since the BoR only meets twice a month, sometimes re-affirmation

prior to 30 days having elapsed occurs, depending on the BoR's schedule of meetings, which is what occurred at the January 3rd meeting.

Also, at the December meeting, the BoR received a presentation by the consultant of a final Report on the results of a market-based study of compensation of the five positions that are actual VCERA employees. No action was taken that day but, on January 3rd, the BoR approved creation of an ad-hoc committee to negotiate the implementation of the recommendations contained in the study with the affected employees. The committee consists of me, as Chair, Public Member Tommie Lee Joe, and General Member Jordan Roberts.

At the same meeting, the BOR considered a proposal I made to add several positions to the roster of VCERA employees, and to add some title changes to the law. My proposal failed to gain support. Instead, the BoR established an ad-hoc committee to work with the County to create some new positions similar to what were proposed in the legislation, but the persons serving in those positions would be County employees rather than VCERA employees. I was extremely disappointed in the BoR's decision. In any event, Chair Sedell appointed himself as Chair of the committee, with me and Safety Member Robert Ashby as the other members.

Although the final date isn't in from the Federal Bureau of Labor Statistics, it is a pretty good guess that all retirees who are eligible will receive a 3% COLA next April, with some percentage added to their COLA bank. I will deal with the final numbers in the next newsletter. Of course, the eligible represented employee retirees will also receive their 2% increase.
