RETIREMENT BOARD NEWS - BY ART GOULET

For the past several years, most investors have experienced cycles of one or two years of investment gains followed by one or two years of losses. As you'll recall, VCERA experienced spectacular returns in the 2020-21 fiscal year. In January 2022, the markets



began pulling back because of inflation rates hitting 40-year highs, driven by a confluence of headwinds including continuing supply chain difficulties, the war in the Ukraine, U.S.-China political and trade issues, seemingly never-ending new COVID variants, and excess liquidity in the market.

The preliminary investment returns for the 2021-22 fiscal year show a loss of roughly 6.2%, reducing VCERA's asset value to about \$7.00 billion from about \$7.42 billion at the end of the previous fiscal year. Private market asset classes typically lag the public markets in determining their final results. VCERA's investment consultant estimates that when all results have been finalized, the actual loss for the fiscal year will be slightly lower. By way of contrast, the median public pension fund reported a larger decline of 10.5% for the 2021-2022 fiscal year.

Though the recent investment returns are disappointing, it emphasizes the value of VCERA's defined benefit (DB) pension plan as compared to a defined contribution (DC) plan (such as 401k or an IRA). A public employee who is a member of a DB plan need not worry about market fluctuations in the short term because his or her retirement benefit does not fluctuate with the market, nor does it get reduced as could occur in the event of losses in the value of assets for those in a DC plan. Additionally, VCERA, like its CERL peers, smooths it gains and losses to achieve a long-term return which VCERA has and will, which is why DB plans work and are superior to DC Plans.

In June and July, the Board of Retirement (BoR) made several new commitments to private equity and private debt on the dates shown, as follows:

- June 20th Harbourvest Dover Street Fund XI (Private Equity \$40 million)
- June 20th Pantheon Credit Opportunities II (Private Debt \$40 Million)
- July 25th Torchlight Debt Fund VIII (Private Debt \$40 Million)

These commitments were made to Managers, with proven track records with which VCERA had previously done business.

Assembly Bill (AB) 826 passed out of the Senate on August 22nd and is back at the Assembly for concurrence in amendments made in the Senate. Assuming the Assembly concurs no later than August 31, it will be sent to the

Governor, who will have the month of September to sign, veto, or allow it to become law without signature. AB 826 is legislation drafted by the County and SEIU with the goal of making 100% of the Flexible Credit Allowance (FCA) pensionable (included in compensation used to calculate retirement benefits) for Legacy members (those hired before January 1, 2013). AB 826, which had previously been in "inactive" status since September 9, 2021, was removed from inactive status on August 3, 2022, and was amended to apply only to those Legacy members who have or will retire on or before December 31, 2025. Before the most recent amendment, the non-cash portion of the FCA would have been pensionable for Legacy Members regardless of when they retired. However, the landmark Alameda Decision clearly said that benefits such as the non-cash portion of the FCA are "in-kind" benefits and not pensionable and, in fact, CERL Plans never had the authority to include them as pensionable in the first place. The bill, as amended recently, also provides for return of contributions to Legacy Members who fail to meet the December 31, 2025, deadline for retirement. Also, the bill now only applies to VCERA.
