#### **Greetings REAVC Members,**

The oral argument for the REAVC appeal of the VCERA decision regarding the reduction of retirement benefits is scheduled to be heard before the Court of Appeals on November 9, 2023. The involved unions and VCERA will also be appearing at this hearing before a panel of appellate justices. REAVC is represented by Michael Walker, former Assistant Chief County Counsel with the County, and now with the law firm Norman Dowler, LLP. Several

REAVC board members will be in attendance as well as several of the listed "Amici," or friends of the court.

The decision to join the appeal against the retirement benefits deductions was a carefully considered and important decision made by your REAVC Board with the primary concern being the wellbeing of County retirees. We will keep you apprised of the results of the oral argument.

#### **RETIREMENT BOARD NEWS - BY ART GOULET**

I last reported that the preliminary investment returns for the 2022-23 fiscal year showed a gain of roughly 8.5%, not including investment performance calculations in private market asset classes, which typically lag the public markets. When all results were in, the gain for the fiscal year remained the same, with VCERA's assets valued at \$7.51 billion.



At risk of sounding like a defective recording, the market continued to be volatile. July was an up month with the portfolio ending at \$7.80 billion while August was a down month and VCERA's portfolio value ended up at \$7.66 billion. September was also a down month, with VCERA's portfolio dropping to \$7.43 billion.

The Board of Retirement did not meet in August.

At its meeting of September 11<sup>th</sup>, the Board presented a resolution to Linda Webb in recognition of her many accomplishments as Retirement Administrator. She received it via Zoom.

At the same meeting, the Board revised and renewed two very important contracts related to VCERA's Pension Administration System, V3. The first was the Vitech Support and Maintenance Agreement which included the prepurchase of 2000 hours of support services. One of the priority uses of these hours will be to revise V3 as necessary to assist in the implementation of the Alameda Decision over the next several years. The other was the Hosting Agreement with VSG Hosting, for the support and cloud hosting of the V3 application.

At its September 25<sup>th</sup> meeting, the BoR made commitments to invest in a private credit fund and two infrastructure funds as indicated below:

- \$20 million commitment to Bridge Debt Strategies Fund V. VCERA has previously made private credit commitments to two Bridge funds; \$25 million to Bridge Debt Strategies Fund III in September 2019, and \$25 million to Bridge Debt Strategies Fund IV in July 2021.
- \$75 million commitment to Harbourvest Partners Infrastructure Opportunities Fund III. VCERA previously committed \$\$100 million to Harbourvest Real Assets Fund IV (which has since been renamed Infrastructure Opportunities Fund II) in 2019.
- \$25 million commitment to Pantheon Global Infrastructure Fund IV. Although this is the first Pantheon infrastructure fund VCERA will be investing in, since 2010 VCERA has committed \$165 Million to other Pantheon Funds.

While VCERA conducted business on September 25<sup>th</sup>, the meeting was primarily a Retreat focused on Education and the Board heard excellent presentations entitled "Fewer Losers or More Winners" (Strategies for Fixed Income Investments), "Transformative Year Ahead" (Implications of World and National events on the economy and market), and "Policy Board: Fiduciary Governance Education".

October 23<sup>rd</sup> was the BoR's only meeting in October. At the meeting, new BoR members Anthony "Tony" Rainey and Donald "Don" Brodt were sworn in. Tony is a Public Member and Don is the Alternate Public Member, both appointed by the County Board of Supervisors.

Also at the meeting, the BoR made a commitment of \$25 million to PIMCO Aviation Partners II. This investment will fit into VCERA's real assets class. VCERA has previously committed a total of \$205 million to three PIMCO private credit funds in 2019, 2020, and 2022.

#### CalPERS Long Term Care Insurance Settlement Finalized!

The settlement became final on September 28, 2023. No appeals were filed against the settlement.

#### **Category A Class Members who elected Option 1 – Premium Refund:**

The information in this paragraph only applies to Class Members who elected to surrender their Policies and receive an 80% premium refund (less any benefits received).

The Final Settlement Date was September 28, 2023, which means your CalPERS LTC Policy will be surrendered and you can stop paying premiums as of that date. You will be notified in January 2024 of your final refund amount, but please understand that it will include 80% of all premiums paid to CalPERS (less any benefits received) through the Final Settlement Date. We have been advised by CalPERS that premium payments deducted from Class Members' pension checks—or that are set up for autopay through their bank accounts—should stop automatically, and any payments

deducted after September 27 will be refunded by CalPERS. If you make the payment to CalPERS by check, you should stop sending premium payments.

## Class Members who elected Option 1 but recently went On-Claim, applied to go On-Claim, or think they may need to go On-Claim:

If you elected Option 1, but applied to go On-Claim or went On-Claim before September 28, 2023, or believe you may need to go On-Claim before October 28, 2023, then you may qualify for Category I or another process provided for in the Settlement that would allow you to reverse your election. #### CALPERS LONG-TERM CARE LAWSUIT UPDATE FROM THE OCTOBER CRCEA BUSINESS SESSION MINUTES

LONG-TERM CARE: MIKE SLOAN REPORTED A SETTLEMENT HAS BEEN REACHED. FOLLOWING ARE DETAILS PROVIDED BY THE ATTORNEY PERTAINING TO THE SETTLEMENT. THIS INFORMATION WILL ALSO BE DISTRIBUTED VIA EMAIL TO ALL ASSOCIATIONS AND POSTED ON THE CRCEA WEBSITE: WWW.CRCEA.ORG.

THE SETTLEMENT BECAME FINAL ON SEPTEMBER 28, 2023. NO APPEALS WERE FILED OF THE SETTLEMENT. THE WEBSITE WILL BE UPDATED THIS AFTERNOON TO REFLECT THAT THE SETTLEMENT HAS BECOME FINAL.

SETTLEMENT CLASS MEMBERS WHO ELECTED OPTION 1, TO SURRENDER THEIR POLICY AND RECEIVE A PREMIUM REFUND, MAY STOP PAYING PREMIUMS. IF PREMIUMS ARE AUTOMATICALLY DEDUCTED FROM THEIR PENSION, CAL/PERS HAS ADVISED THAT THOSE DEDUCTIONS WILL STOP **AUTOMATICALLY.** CAL/PERS HAS ALSO ADVISED THAT ANY PREMIUM PAYMENTS MADE FOR COVERAGE BEYOND SEPTEMBER 28, 2023, OR ANY PENSION DEDUCTIONS THAT OCCUR IN ERROR, WILL BE REFUNDED TO CLASS MEMBERS IN FULL. SO, IF SOMEONE ELECTED OPTION 1 AND PAID THEIR OCTOBER PREMIUM, THEY WILL RECEIVE A 100% REFUND OF THAT PAYMENT. THOSE REFUNDS WILL BE PROVIDED SEPARATELY BY CAL/PERS AND WILL NOT BE INCLUDED IN SETTLEMENT PAYMENTS.

SETTLEMENT PAYMENTS WILL BE MAILED OUT VIA CHECK IN JANUARY 2024 (CAL/PERS HAS UNTIL 75 DAYS AFTER THE FINAL SETTLEMENT DATE TO PROVIDE UPDATED DATA; TO LIQUIDATE SUFFICIENT ASSETS; AND TO FUND THE SETTLEMENT. THE SETTLEMENT ADMINISTRATOR THEN HAS 30 DAYS TO DISTRIBUTE THE FUNDS TO CLASS MEMBERS. SO, 105 DAYS AFTER SEPTEMBER 28 RESULTS IN A DEADLINE OF JANUARY 11, 2024. SETTLEMENT CHECKS WILL BE MAILED OUT BEFORE THAT DATE).

IF YOU LOOK ONLINE AT THE COURT'S DOCKET, YOU WILL SEE THAT AN APPEAL WAS FILED. DO NOT WORRY. WE FILED THAT APPEAL. IT HAS NOTHING TO DO WITH THE SETTLEMENT, AND CAL/PERS HAS AGREED THAT IT WILL NOT INTERFERE WITH THE SETTLEMENT BECOMING FINAL. THE APPEAL CONCERNS A COURT ORDER FROM 2020 STRIKING THE CLAIMS OF PEOPLE WITHOUT INFLATION PROTECTION.

"Grow old along with me! The best is yet to be, The last of life, for which the first was made:"-- Robert Browning



"Pigs Is Pigs" is a short story by American writer Ellis Parker Butler published in 1905. The main character is a railroad station agent named Mike Flannery.

Railroad agent Flannery insists on charging the livestock rate for a shipment of two guinea pigs and refuses to allow the lower pet rate, saying "pigs is pigs, and rules is rules." The customer refused to pay the higher rate (a total price difference of ten cents) and would not accept delivery. Flannery was forced to feed and house the two guinea pigs in his office. When he eventually received instructions from railroad high command to accept the lower price, he discovered that the customer has vamoosed, left town, took the noontime bus - Gus and now Railroad agent Flannery have a few more guinea pigs on his hands.

He was instructed by his superiors to return the pigs to the company warehouse. By this time, the two guinea pigs have reproduced exponentially and have taken over the entire railroad station. After carting up and mailing all the pigs to the main railroad office (including <u>ALL</u> the descendants), Flannery resolved to charge the lower rate for any future livestock.
