GOOD NEWS!

On April 17, 2024, the Supreme Court of California granted the two county unions a petition for review. This is very good news indeed because only 3% of the petitions are granted review by the Supreme Court. We appreciate the great work done by the Alameda Committee, membership signatures, the unions, and the REAVC Board. The Alameda Committee will be discussing the next steps in filing an amicus brief with the Supreme Court and recommendations will be presented to REAVC Board for consideration.

MESSAGE FROM REAVC PRESIDENT - REDDY PAKALA

REAVC continues to work on protecting county retirees' benefits from reductions by the Ventura County Employees' Retirement Association (VCERA). As I reported in the March - April newsletter, the Court of Appeals affirmed the Superior Court decision on January 4, 2024, regarding the Criminal Justice Attorney's Association of Ventura County, et, al (Appellants) appeal. REAVC and other senior county managers supported the appellant's position in the Appeals Court.



On February 27, 2024, Appellants petitioned the Supreme Court of California for review of the published opinion of the Court of Appeals. On March 13, 2024, REAVC and eight other retired county of Ventura officials filed an amicus curiae brief in support of the petition for review of the Appellant's filing in the Supreme Court of California. On March 14, more than 450 retired county employees asked the Supreme Court for review to eliminate the adverse impact of actions by VCERA in its implementation plan. Each listed retiree provided consent.

Both the March 13 and March 14, 2024, letters supporting petition by Appellant for review by California Supreme Court are posted on the REAVC website and were emailed to those who consented for review by the Supreme Court.

Now, we wait for the Supreme Court to decide to hear the appeal.

On February 26, 2024, REAVC attended the regular meeting of the VCERA Board and submitted a letter to VCERA asking its board to amend the resolutions implementing the reductions on a prospective basis only. Several REAVC board members, retired county department heads, an elected official, and former county CEO Marty Robinson testified opposing VCERA's actions. A copy of the letter to VCERA follows.

VCERA from REAVC

Subject: Request for Review of VCERA's Alameda Resolution Adopted October 2020

Members of the VCERA Board:

REAVC is writing you today to request that you schedule a date to conduct a review of the VCERA Alameda Resolution adopted on October 2020, for the purpose of discussion and adoption of potential revisions.

The primary reason for this request is as follows: VCERA now has two court decisions, the latest a precedential decision by the Appellate Court in Ventura, which state in clear language that VCERA <u>MUST</u> apply the California Supreme Court "Alameda" Decision on a prospective basis, and that it <u>MAY</u> apply the Decision retroactively to January 1, 2013.

Since it is now clear that VCERA is <u>NOT</u> required to affect the pensions of retirees since 2013, we question why VCERA would do so. By exercising your authority to apply the Alameda Decision prospectively only, you would eliminate the expense of calculations, notices, appeals, and related work, all of which is funded by money provided for the benefit of retirees, and by retirees. It would cause no harm to retirees, many of whom have been retired for years and are already suffering the stress of recent high inflation, with no COLA. You would also avoid further damage to VCERA's reputation among retirees, current employees, and prospective job applicants.

Based on the court decisions, and your authority outlined within them, we urge you to amend the VCERA Resolution, applying application on a prospective basis only, on a date on or after September 1, 2020, as cited by the courts. The Supreme Court's Alameda Decision was issued on July 30, 2020. It was not final until August 31, 2020. As both court decisions point out, prospective adjustments would be effective, at the earliest, on September 1, 2020.

VCERA RETIREMENT BOARD NEWS - BY ART GOULET

VCERA's portfolio increased in February to \$8.02 billion after earning 2.3% in the month, followed by earning 2.1% in March and ending at \$8.17 billion. Thus far this fiscal year, the fund has earned 9.8%, with three months remaining.



At its March 25th meeting, the BoR committed \$25 million to Harbourvest Partners'
Co-investment Fund VII, adding to its Private Equity portfolio. Harbourvest is a longtime investment partner of VCERA's.
Before this commitment, Harbourvest was already managing approximately \$258.8 million of VCERA assets across eleven of its private equity, private credit and real assets funds.

As I reported in the last Newsletter, at the February 26th BoR meeting, I made a motion to: "Request that Staff Provide an Analysis to the Board that Explains the Comparison of VCERA's Decision on Applying the Leave Straddling Issue to those CERL Systems that Applied the Law Differently, and Why it May Not be Applicable to VCERA." This analysis was presented at the March 25th BoR meeting. Staff reported that out of 20 CERL or 1937 Act county retirement systems:

- Eleven systems either did not have an issue or had resolved any straddling issue or had resolved any straddling issues prior to PEPRA becoming effective on January 1, 2013.
- Seven systems (including VCERA) excluded straddling after the effective date of PEPRA or after the Supreme Court's "Alameda" decision on July 30, 2020, applying such elimination to members who had retired on or after January 1, 2013.
- Two systems (ACERA and SBCERA) excluded straddling after "Alameda" and applied the elimination to members who retired on or after the effective date of "Alameda" or the date their BoR adopted an "Alameda" implementation resolution or plan.

Of the nine systems that eliminated straddling, only VCERA litigated the matter and the outcome of the case, which was affirmed by the Appellate Court, is binding on VCERA.

Quoting from the Appellate Court decision, "While we appreciate the impact of the Board's resolution on members' retirement allowances, we nonetheless conclude the Board was <u>required</u> to comply with section 31461, subdivision (b) and Alameda and exclude compensation for unused leave exceeding their calendar year allowance." (Emphasis added)

It should also be noted that "Alameda" held "It is the law in effect at the time of retirement that is used to calculate the amount of an employee's pension benefit." The Court of Appeal in VCERA's straddling litigation stated, "We follow the Supreme Court's analysis of subdivision (b)(2) and (4) to conclude that amended section 31461 requires exclusion of compensation for leave cashouts that exceed the one (or three) calendar year's limits for such cashouts for purposes of calculating legacy members' retirement benefits.(Emphasis added). Section 31461(b) was added to CERL effective January 1, 2013, which is why any Legacy member who retired on or after that date must have their pension reviewed to ensure their final average compensation and retirement benefit was not increased due to straddling. In VCERA's straddling litigation, the only argument raised in challenge to VCERA's application of straddling rules to those who retired on or after January 1, 2013, was with respect to estoppel and fairness principles, and the trial court clearly rejected those arguments. The estoppel and fairness arguments were not raised on appeal and will not be subject to further review in the event the Supreme Court accepts review in response to the CJAAVC and VCPPOA unions' petition for review, which was filed on the very last day they could do so. There is no automatic right to be heard on civil cases in the California Supreme Court and only about 3% of cases filed in the Court are reviewed.

Several REAVC Board members appeared at the March 25th meeting to again request that the Board reconsider its October 12, 2020, Resolution, which set the effective date for implementation of all PEPRA amendments to CERL, including the straddling exclusion, as January 1, 2013. These retirees asked that the Board instead apply the straddling exclusion effective as of the "Alameda" decision (7/30/20) or later.

Several times previously the REAVC Board or its President have, either verbally or in writing, alleged that "many" CERL retirement systems had set later effective dates than VCERA. As may be seen from the previous tabulation of what CERL systems had done, that is not accurate. Further, it has been pointed out previously Retirement Boards have no legal authority to create "window periods" that permit members to receive retirement benefits that the applicable law does not authorize.

As I noted in my last Newsletter article, VCERA has published a news item at www.vcera.org/alameda entitled "Leave Straddling FAQs." The online post summarizes the recently litigated "leave straddling" issue and how certain retired Legacy members could be impacted. The article also links to a four-page document that addresses frequently asked

questions (FAQs) on the subject, including examples of how "leave straddling" calculations will be performed post-Alameda. Also, the Power Point presentation by VCERA's outside counsel that I mentioned in my last article is also available online at the same site. As a reminder, should a Legacy retiree's benefit be reduced due to inclusion of straddled leave buyback in determining final average compensation used in computing the benefit, the BoR stipulated in the litigation it will not seek recovery of the overpaid amount.

The recruitment to replace Amy Herron as VCERA's COO after her appointment as Retirement Administrator is completed. Betsy Byrne was appointed to the position and has reported to work. She was previously the head of the Payroll Division in the County Auditor-Controller's Department.

It's important to point out to my readers, although I am a member of the REAVC Board, I recuse myself from all REAVC Board discussions concerning REAVC's support of litigation against VCERA, retention of counsel, and the financing thereof.
