## UPDATE ON THE JUNE 4 SCHOLARSHIP LUNCHEON

The atmosphere was warm and welcoming as close to 140 Retirees and guests signed in for the quarterly luncheon. Seven of the ten scholarship recipients, who were to be honored, attended with family and guests. After the initial opening remarks, an update was given on the Alameda Case and the work that is being done now by REAVC to protect retiree pensions. REAVC Board members have formed a committee and continue to present their concerns at the VCERA (Ventura County Employees’ Retirement Association) monthly Board meeting. The issue has now been accepted by the California Supreme Court for hearing. Lawyers have donated many hours of legal advice to REAVC, but moving forward there is a need to ask the members for additional funding to assist with the costs of a presentation to the Supreme Court. Please look in upcoming newsletters for additional information on this important topic and all that is being pursued to protect your pensions and those of future employees.

The scholarship committee had applications from high school graduates (2024) to students working on their PhDs. All are bright, motivated and tireless young people who have goals to improve the world around them. Ten students were awarded one thousand dollars toward their tuition, books, etc.

Scholars shared gratitude to family members, parents and grandparents who have supported them and to REAVC for the financial contribution to their education. Listening to what they have accomplished these past years gives us all great hope about their contributions to our future.

Once again, the Chef and staff at Sterling Hills gave us delicious choices for our varied appetites. The Quarterly Luncheon is a valuable way to stay connected with past friends and co-workers and /or re-connect with those you may not have seen in years. ## IMPORTANT NOTE REGARDING LUNCHEON “NO-SHOWS” AND CANCELLATION DEADLINES

REAVC is obligated to pay the full price (close to \$40) for ALL luncheons reserved, regardless of whether people attend. It is disappointing and an unnecessary expense for REAVC to pay for a meal that no one eats. Last-minute cancellations and no-shows at the luncheons are an issue for REAVC because they cause unnecessary expense to the general membership.

To address this issue and keep luncheon costs to members at \$10, the REAVC Board established the following policy: Members who make reservations and do not show up or fail to cancel by the required date noted on the reservation form will be asked to pay the balance for the full cost of the meal, which is \$40. Therefore, you must cancel on or before the required date!

Of course, we recognize that emergencies may prevent you from submitting a timely cancellation or cause you to miss the luncheon. In that case, you may call (805) 644-7814 to request a waiver of the additional charge.

## VCERA RETIREMENT BOARD NEWS – ART GOULET

April’s investment results were disappointing, with a 2.0% loss bringing the portfolio value down to \$7.97 billion, or slightly below March’s. However, the month of May saw a market rebound with the portfolio gaining 2.7%, boosting the market value to \$8.16 billion. For the fiscal year through May 30<sup>th</sup>, earnings have been 10.4%

At its April 29<sup>th</sup> meeting, the BoR approved a three-year extension of its contract with the Segal Company, VCERA’s long-time Actuary.

On May 20<sup>th</sup>, after thorough deliberation and joint recommendations from the Chief Investment Officer (CIO) and the Investment Consultant, the BoR approved minor adjustments to VCERA’s Asset Allocation targets, ranges, and benchmarks. These changes, to be phased in over the next three years, aim to slightly reduce risk while enhancing long-term gains.

The crucial role of the CIO, in collaboration with the Fiscal Staff, often goes unrecognized. They ensure that VCERA meets its retiree payroll obligations each month and has the cash needed to cover capital calls from our Private Market Managers.

VCERA welcomes Anikka Abbott as the new Communications Officer. Anikka holds a master’s degree in mass communication from the Walter Cronkite School of Journalism and Mass Communication at Arizona State University. 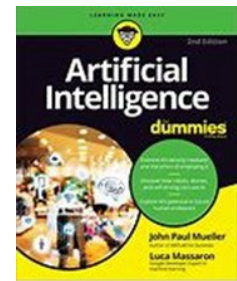
Also, VCERA is actively recruiting for an Investment Officer to assist the CIO. The number of VCERA’s investments, especially in Private Markets, has increased substantially and grown more complex, necessitating additional support. More than 100 applications were received and are currently being reviewed.

Finally, VCERA-sponsored SB 1189 (Limon), which would add a CTO to the list of positions that may be VCERA, rather than County, employees passed out of the Assembly on June 26 and went to the Governor for signature. There is no registered opposition to the bill.
