#### MESSAGE FROM REAVC PRESIDENT – REDDY PAKALA

This message covers a variety of subjects that I thought might interest REAVC members.

First, I hope you are in good health and happiness. We all worked hard to earn our retirement pensions, and I hope you are secure and happy in your Golden Years. REAVC exists as an organization to provide an avenue for social interaction, timely information for our members, and to do its best to protect the pensions that we rightfully earned.

We are still waiting for the California Supreme Court's ruling on the "Alameda Decision," which affects pension benefit reductions for county retirees who retired on or after January 1, 2013. Supreme Court oral arguments will likely be scheduled for December or early next year. It's a fun time of year, preparing to celebrate Christmas, Hanukkah, and Kwanzaa, just after watching out for little gremlins, princesses, and ghosts on our streets.

Pacific Group Agencies (PGA) is an insurance broker that has provided insurance services to many county retirees, including REAVC members, for several years under an existing agreement. Recently, another firm, Association Member Benefits Advisors (AMBA), acquired almost all of PGA's assets. The existing agreement allowed PGA to contact REAVC members annually by mail. PGA offered a range of insurance services from multiple insurance companies at discounted group rates.

AMBA/PGA recently shared a revised draft agreement with us for review, but the REAVC Board found some provisions in this draft undesirable. Your Board is considering working with AMBA/PGA to revise and negotiate a new agreement with them or explore other group insurance options.

In October of this year, PGA sent out its annual mailer. The individual insurance products offered are and continue to be backed by the respective insurance companies, and the acquisition of PGA and AMBA should have little to no impact on any individual policies that REAVC members may currently hold.

Under the terms of REAVC's By-laws, the REAVC Board of Directors has reappointed Colleen Bruns, Ben Emami, Maeve Fox (alternate VCERA member), Art Goulet (VCERA Board member), Roberta Griego, Will Hoag, and Tracey Pirie to serve another term as REAVC Board members. I thank all sixteen current Board members, including those willing to serve another term. #### **VCERA RETIREMENT BOARD NEWS - BY ART GOULET**

In my article in the last newsletter, I reported the preliminary investment return of 11.8% for the past fiscal year, At the time, I noted private market earnings are typically reported about three months after the close of the fiscal year and VCERA's investment consultant expected the final results would be even stronger. The end of quarter final results are now in. The total fund's market value came in about \$5 million higher than the preliminary estimate, **b**ut the final portfolio one-year rate of return was still at 11.8% when rounded to one decimal point. The \$5 million difference, when compared to a portfolio of more than \$9 billion, seems insignificant. However, plagiarizing a quip attributed to former Senator Everett Dirkson, "A million here and a million there, and pretty soon you're talking about real money!"

Through July, August, and September the positive momentum continued. In July, the portfolio gained 0.8%; in August, 2.0%; and in September an additional 2.1%, bringing month end portfolio market values to new highs of \$9.10 billion; \$9.25 billion; and \$9.45 billion, respectively— an increase of more than \$400 million since July 1.

At its September 8<sup>th</sup> meeting, the BoR committed \$40 million to Sixth Street Specialty Lending Europe Fund III, a private credit fund investing in European credit opportunities primarily in the United Kingdom, Western Europe, the Nordic countries, Spain and Italy.

On October 27<sup>th</sup>, the BOR followed up with two additional private credit fund commitments of \$40 million each. These were FoxPath Credit Secondaries Fund and Pathlight Capital Fund IV. Foxpath's portfolio will be primarily focused (70%) in North America with the balance in Western Europe. A secondaries fund acquires its assets from primary fund owners, usually at a discount, which provides the possibility of higher returns because of the lower cost basis. Pathlight will invest primarily in 1<sup>st</sup> lien asset-based term loans to companies headquartered in North America.

The target allocation for VCERA's globally diversified private credit program is 10% of the portfolio. As of June 30, 2025, approximately 8% of assets have been invested in this program.

Also at the September 8<sup>th</sup> meeting, the BoR considered reports from its Actuary regarding risk assessment and smoothing of employer contributions to amortize unfunded accrued actuarial liability (UAAL). After discussion, the BoR decided to undertake a risk assessment every three years and to revise its Actuarial Funding Policy as the Actuary recommended.

The BoR was also advised that customer support for VCERA's pension administration system will no longer be provided subsequent to July 11, 2028 and the staff will be undertaking a multi-year effort to obtain a new system either from the same or new vendor.

The BoR's September 29<sup>th</sup> meeting was a Retreat at which it received excellent presentations by financial experts

regarding various aspects of the public investment markets and their predictions for the future.

The BoR also heard presentations by staff including a refresher course of the many adopted BoR policies, an introduction to AI, and a review of the new Communications Officer's activities and accomplishments during the past year.

At its October meeting the BOR updated VCERA's tax compliance regulations to conform to recent changes in federal tax law and to conform with VCERA's current practices. This was an important step in insuring VCERA will retain its tax-qualified status. The benefits of qualification are that employee contributions are pre-tax and VCERA's earnings are not taxable.


